JOB SUMMARY:

The Upper Mattaponi Tribe is looking for a highly skilled and motivated Community Service Director to create, oversee, and coordinate health-related programs and services within our tribal community. The Upper Mattaponi Tribe consists of just under 700 citizens with diverse health and wellness needs. The ideal candidate will have a passion for community health, strong leadership skills, and the ability to work collaboratively with diverse stakeholders to improve the health and well-being of our community.

MAJOR DUTIES & RESPONSIBILITIES:

- Formulate and administer community health programs based on needs and available resources to promote the overall well-being of the tribe.
- Develop and manage budgets for community health programs, ensuring efficient allocation of resources and adherence to financial constraints.
- Establish community health policies and regulations that align with best practices and tribal needs.
- Lead a diverse team of community health staff (i.e. social workers, program coordinators, volunteers), providing guidance, support, and mentorship to ensure the successful implementation of programs.
- Design and implement strategies to raise awareness about key health issues, prevention strategies, and available resources within the tribal community.
- Build and maintain strong relationships with community organizations, healthcare providers, and other stakeholders to foster collaboration for health initiatives.
- Gather data to assess community health needs, identify trends, and evaluate program effectiveness.
- Ensure compliance with all federal, state, and tribal regulations including fiscal policies, governing community health, and reporting.

KNOWLEDGE, SKILLS, AND ABILITIES REQUIREMENTS:

- Strong leadership and communication skills.
- Familiarity with tribal community dynamics and needs.
- Strong understanding of public health principles and policy in regard to federal, state, and tribal regulations.
- Proficient in Microsoft Office (Word, Excel, Teams, Outlook).
- Strong organizational skills.

EDUCATION and/or EXPERIENCE:

- Masters's degree in public health, social work, health administration, community development, or a related field from an accredited college or university.
- At least 4 years of experience in community health program management, 2 of those being in a supervisory role.

OTHER REQUIREMENTS:

- Must have excellent communication skills must be able to communicate clearly and concisely.
- Must be able to organize time, solve problems and carry out duties with a minimum of supervision, as well as work cooperatively with other staff.

- Must possess a valid State Driver's License.
