JOB SUMMARY:

The pharmacist is assigned to the UMT and Aylett Family Wellness Center outpatient pharmacies of the Upper Mattaponi Tribe Health System in King William County, Virginia. The Pharmacist role is to assure access to the safe and effective use of medications.

PRIMARY DUTIES & RESPONSIBILITIES:

- Processing and dispensing medications in an outpatient clinic and retail pharmacy setting.
- Practice in a true pharmaceutical care environment, apply clinical knowledge and skills to improve outcomes.
- Monitoring patient drug therapies, advising interventions, and informing patients of potential side effects.
- Instructing patients on how and when to take prescribed medications.
- Completing operational requirements of the pharmacy, including verifying order entries, maintaining records of controlled substances, charges, and pharmacy inventory management.
- Adhering to applicable legal rules, regulations, and procedures governing pharmaceutical practice.
- Distributive function assignments and assist in management of pharmacy operations.
- Integrate with community healthcare providers to improve patient outcomes and access to care.
- Contribute to continuous total quality improvement activities for the pharmacy department.
- Assists in the training of pharmacy technicians, peer pharmacists and pharmacy students.

QUALIFICATION REQUIREMENTS:

- Degree in Pharmacy
- Current Virginia pharmacist license
